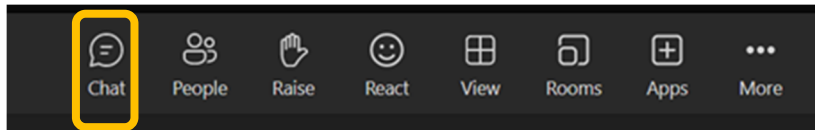
- Please leave time to correct any installation issues, review the meeting agenda and perform a tech check.

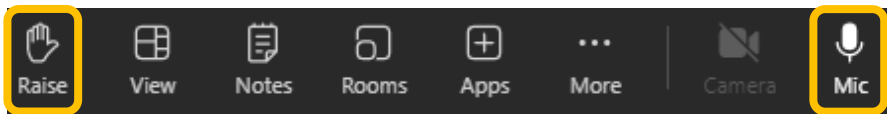

For attendees on Teams who wish to submit a written question, select 'Chat', type your question in the text box, and then select Send.



For attendees who wish to speak, select the 'Raise your hand' icon. Host will call your name, click the 'Mic' icon to unmute.



Call-In attendees can dial \*5 to raise their hand to be recognized. When recognized, \*6 to unmute.
