Date/Time: Thursday, September 13, 2007, starting at 6:30 p.m.

Location: Conference Center, Shea Memorial Drive (off Route 18), NAS South Weymouth

Notice of Availability of Proposed Plans: The Navy's Proposed Plan for the former Sewage Treatment Plant is available for review. The Plan proposes a remedy under the Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA). The public is encouraged to review the information and provide comments.

Notice of Public Comment Period and Meeting: The formal comment period for the Proposed Plan is from August 29, 2007 to September 28, 2007. On September 13, 2007, the Navy will hold an informal poster session from 6:30 p.m. to 7:00 p.m. A public meeting will follow from 7:00 p.m. to 8:00 p.m., during which the Navy will provide technical

presentations and host a question-and-answer session. Finally, the Navy will hold a formal public hearing from 8:00 p.m. until all comments are heard. During this hearing, the Navy will accept oral comments and an official transcript of comments will be recorded.

Both oral and written comments will be accepted during the 30-day comment period. The Navy will work closely with the U.S. Environmental Protection Agency (EPA) to determine the final remedy after the comment period ends and all comments have been considered.
