Dear Mr. Davidson:

I have completed my review of the Long-Term Monitoring Plan, Operable Unit 10, Sites 21 and 25 and Operable Unit 11, Site 45, NAS Cecil Field, dated April 2002 (received April 3, 2002). The following comment should be addressed in the final document:

(1) On page 1-1, Section 1.1.1, it states that soil removal was conducted to support residential reuse. This is incorrect. The Interim Remedial Action conducted has cleaned up the site for industrial reuse. Only recently has the BRAC Cleanup Team investigated cleaning the site up for residential or unrestricted reuse.

(2) For Site 21, monitoring well identification number CEF-P21-01S is used for two separate wells that are being used for separate purposes as specified in the Long-Term Monitoring Plan. The CEF-P21-01S well that is to be sampled and analyzed for pesticides was formerly referred to as well 90G00101/CEF-AOI21-1S. This well is shown on Figures 1-3 and 2-1 as being located south of Building 370 and west of Building 874. The other well identified as CEF-P21-01S is shown in Appendix A, Figure A-1, as being to the east of Building 371. Water level measurements have been taken from this well in order to create the potentiometric surface map depicted in Figure A-1. The previously mentioned well, CEF-P21-01S is shown as being well 90G001 on that figure. Please change the document so that it is very clear which well is which, and what information is to be taken from the wells. This should mean changing the identification number of one of the wells.
