Dear Mr. Davidson:

I have completed my review of the Draft Declaration of the Explanation of Significant Differences (ESDs), Naval Air Station Cecil Field, dated June 2003 (received June 20, 2003). The ESDs provide for enforceable Land Use Control (LUC) provisions for Operable Unit 1, Sites 1 and 2; Operable Unit 2, Sites 5 and 17; Operable Unit 3, Site 8; Operable Unit 7, Site 16; Operable Unit 8, Site 3; and Operable Unit 9, Sites 36 and 37. These enforceable LUC provisions will be part of the Record of Decision for each site. In addition to concurring with comments submitted by the U.S. EPA on this document, I have the following two minor editorial comments:

- (1) On page 2, first paragraph on the page, last sentence of the paragraph, please replace "reflected" with "as specified".
- (2) In Table 1, the OU 9, Site 36 & 37 row, LUC Summary column, "prohibit" is misspelled.

Otherwise, I found the document adequately addresses those changes that are required in the Records of Decision for sites requiring Land Use Controls. If you have any concerns regarding this letter, please contact me at (850) 245-8997.
