The Florida Department of Environmental Protection has reviewed the Record of Decision for Operable Unit 10, Site 25, Naval Air Station Cecil Field, signed by the Navy on July 9, 2004 and signed by EPA on September 29, 2004. The Department concurs with the selected remedy as written in the Record of Decision for Site 25. The selected remedy for Site 25 consists of No Further Action regarding soils, Groundwater Monitoring and Land Use Controls. The Department concurs that this remedy should be protective of human health and the environment. However, should the selected remedy prove to not be protective, the Navy is required to abide by those provisions concerning the Contingency Remedy specified in the Record of Decision.
