Dear Mr. Hayworth:

I have reviewed the subject document dated July 25, 2013. The document was received on July 30, 2013.

The Purpose and Scope section of the report states "*TriEco, LLC (TriEco), in conjunction with Tetra Tech, Inc., performed a site assessment (SA) at the Site 1241 Parking Area, Naval Station (NAVSTA) Mayport, Jacksonville, Florida, for the Naval Facilities Engineering Command Southeast (NAVFAC SE)...The data collected during the investigation were used to prepare a Site Assessment Report (SAR). Information from the field investigation has been assimilated into this SAR to provide a characterization of site conditions from which to base future courses of action.*"

This section of the Report goes on to state that "*The purpose of the recently completed SA was to determine if subsurface soils and groundwater at the Site 1241 Parking Area had been impacted by a break in the oily wastewater force main pipeline at this location. This investigation was initiated due to a release that occurred on December 28, 2011 during normal pumping operations of the oily wastewater system.*"


Based on my review of the data presented in the document, TriEco has met the stated purpose of this SA and has prepared this SAR in accordance with Chapter 62-780 requirements. Also, the Department is in concurrence with TriEco's conclusion that, based on the data provided, the site meets the Departments Risk Management Options Level I, No Further Action (NFA) requirements from Rule 62-780.680(1). The Department is in the process of preparing a Site

Rehabilitation Completion Order (SRCO) for Site 1241. Per the Rule [62-780.680(9)], the SRCO shall constitute final agency action regarding cleanup activities at Site 1241.


