1. The Navy Assessment and Control of Installation Pollutants (NACIP) program was authorized by reference (a), which was superceded by reference (b). This program provides for the identification, assessment, and control of environmental contamination from past storage, use and disposal of chemicals and hazardous materials at Navy and Marine Corps activities. Under NACIP, the Naval Energy and Environmental Support Activity (NAVENENVSA) conducts an Initial Assessment Study (IAS) at an activity to ascertain the potential for environmental contamination. The study is coordinated with the cognizant Naval Facilities Engineering Command Engineering Field Division (EFD). If sites posing a potential threat to human health or to the environment are found to exist at an activity, a confirmation study and, if required, projects for corrective measures are initiated by the EFD. An IAS for Naval Activities San Juan Area, Puerto Rico, was approved by the Chief of Naval Operations in reference (c).

2. Enclosure (1) is the final IAS report for Naval Activities, San Juan Area and was prepared for NAVENENVSA by Greenleaf-Telesca, Inc. of Miami, Florida and Ecology and Environment, Inc. of Buffalo, New York. Reference (b) also requires commanding officers to distribute copies of a final IAS to cognizant Environmental Protection Agency regional offices and appropriate state agencies. During the meeting held on 8 August 1984 at Roosevelt Roads, following the final briefings, it was decided that Commander, Naval Forces Caribbean would make the required distribution for the three IAS's completed on Puerto Rico. This should be done within 30 days of receipt of the IAS. Request a copy of the forwarding letter be sent to NAVENENVSA 112N.

3. No sites were recommended for confirmation study, Phase II of the NACIP program, though mitigative action was recommended at three sites.

4. Atlantic Division, Naval Facilities Engineering Command (LANTNAVFACENGCOM) will coordinate all further actions of the NACIP program and will assist the activity to initiate the mitigative actions.
