Dear Mr. Soderberg,

The United States Environmental Protection Agency (EPA) is proposing to enter into an Administrative Order on Consent (Consent Order) with the United States Department of the Navy (the Navy). The proposed Consent Order is intended to set out the Navy's obligations for completing the clean-up of this large, closed military base, pursuant to the authority of the Federal Resource Conservation and Recovery Act ("RCRA"). The Consent Order is projected to replace the 1994 RCRA Permit as the document memorializing these obligations concerning the Naval Activity Puerto Rico (formerly Naval Station Roosevelt Roads). Therefore, the documents provided as a separate submittal are to be made available to the public to support the 30 day Public Review period and a Public Meeting to be initiated soon by EPA via newspaper announcement. These documents should be placed in an area accessible to the public following the EPA announcement in the newspaper. The documents submitted to your office include:


