In accordance with Section 14 of the Federal Facility Agreement (FFA) for the former Alameda Naval Air Station, the Navy is submitting this extension letter for the Draft Record of Decision for Operable Unit 5/IR-02 Groundwater. Delayed funding is the reason for this extension, and funding is now available. There is mutual agreement between the Parties that the specified extension constitutes good cause. With this 90-day extension, the agencies will receive the Draft Record of Decision for Operable Unit 5/IR-02 Groundwater on September 6, 2006, with a 60-day agency review period. The Draft Final and Final Record of Decision submittal dates will be adjusted in accordance with the duration specified in the current Site Management Plan.
