### ***COST RECOVERY AGREEMENT, NATIONAL AERONAUTICS AND SPACE ADMINISTRATION (NASA) CROWS LANDING FLIGHT FACILITY, STANISLAUS COUNTY***

On 11 June 2002, the Regional Board sent NASA a letter titled *Oversight Cost Reimbursement Account, NASA Crows Landing Flight Facility, Stanislaus County* (Letter). This delay in reaching an oversight cost reimbursement account agreement with NASA may adversely impact the schedule for the NASA Crows Landing Flight Facility property transfer.
