This letter is in response to your June 7, 2001, letter regarding Environmental Protection Agency's intention to impose stipulated penalties on the Navy regarding the incidents related to the Parcel E Landfill Fire, Hunters Point Shipyard (HPS). Pursuant to the Federal Facility Agreement (FFA) Section 9, EXTENSIONS, the Navy is requesting an extension to complete its review of, and response to, your letter. Justification for this request as required in FFA Section 9.1 (a) through (d) is provided below:

a. The timetable to be extended is the Navy's submittal of a response to your June 7, 2001 letter.

b. Extension is requested until July 31, 2001.

c. The Navy needs some additional time to fully evaluate the basis of your proposed stipulated penalties and to determine whether the Navy plans to invoke dispute pursuant to FFA Section 14.2.

d. No other FFA requirements are affected by this extension.
