ENVIRONMENTAL PROTECTION AGENCY (EPA) REGIONAL OFFICES

Encl: (1) DUSD (ES) memo dated 15 Oct 1993

1. The EPA recently listed a number of federal facilities that they identified as not having a complete hazard ranking scoring (HRS) package. This list, attached to enclosure (1), was referred to Congressional staff members indicating that the EPA action to identify all National Priorities List (NPL) sites was awaiting information from federal facilities. It is our understanding that Preliminary Assessments (PA) and Site Investigations (SI) have been completed and submitted to the EPA regional offices for most Navy and Marine Corps installations. We need to determine, if in fact, additional information needs to be submitted to EPA.

2. Request you review the attached list of installations within your EFD/EFA area. Please submit the following for each listed Navy/Marine Corps installation:

a. Date the original PA/SI information was submitted to the EPA's office. If information was not submitted, so indicate.

b. Was there an EPA response, either by letter or phone, indicating the submitted information was complete or requesting additional data? If so, please identify EPA's correspondence or your telephone conversation record, date, and point of contact. You may reference the most recent telephone contact with the EPA regional office.

c. If further Navy action was required, please identify the action and when it was taken or will be taken.

d. Any other pertinent information.

3. Request each EFD/EFA submit the status for their listed installations to NAVFAC by 15 November 1993. This information will be presented to Department of Defense at the next Defense Environmental Restoration Program In Progress Review meeting. It will subsequently be passed to Congressional staff members.



SUBJECT: Unevaluated Federal Facilities

At a recent meeting with Congressional staff members, concerns were expressed that DoD installations had not completed Preliminary Assessments and Site Investigations and had not provided accurate information to EPA to permit Hazard Ranking Scoring. EPA Regional Offices have provided us names of installations that may not have submitted complete information.

I request that you review the status of these installations and determine the actions needed to correct any discrepancies.

Please be prepared to discuss your efforts to meet this requirement at the next Defense Environmental Restoration Program In Progress Review.
