Dear Captain Janov:

We thank you and Captain Jones for inviting us to attend the TRC Meeting, May 25, 1993, relative to the Installation Restoration Program for the Long Beach Naval Complex. In our view, the meeting was scheduled at a most appropriate time considering our own limited staff and ever-increasing number of site investigations to be made.

We were particularly interested in the three diagrammatic representations of the "Elements of a Complete Exposure Pathway" and the "Contaminant Migration Pathways" which you included in the handout given us at the recent TRC meeting. The diagrams show clearly how contaminants eventually reach Potential Receptors. Since the Department of Fish and Game has as a primary mission the welfare and perpetuation of fish and wildlife, we subscribe to your process of identifying potential migration pathways which result in the release of toxic substances into adjacent ground water and/or surface water systems.

Sediment contamination presents another area of great concern to us, and we strongly endorse the sediment sampling program the Navy has proposed for Long Beach Harbor (Site 7). In this connection, we are particularly interested in the presence of hazardous materials such as PCBs, organic and inorganic pesticides, dioxins, heavy metals, and other toxic substances.

Since the Department of Fish and Game has been designated by State Law and by the Fish and Game Code 711.7 as a trustee for State fish and wildlife resources, we wish to initiate a meeting with the Navy as soon as possible to discuss a co-trustee responsibility for the protection of fish and wildlife at the Long Beach Naval Complex. Mr. Norman Rial, Environmental Specialist, will be our principal contact for the Department of Fish and Game to coordinate with the Navy for the general protection and conservation of fish and wildlife resources. He will call you in the near future to arrange for such a meeting.
