People with ties to the building, like Mike Groethe, who was hired to make occasional repairs to the strip mall's roof, sinks and toilets, stood on the sidewalk across the plaza and stared.

Wednesday morning, Groethe said he drove past the plaza and said, "Oh no, my building's gone."

Dung Le, the former owner of DBT Market, the liquor store that burned down, said he empathized with the business owners, including the in-

dividual who bought his shop last month. Fire and city officials said the building would have to be torn down because it is unsafe, but could not say

when.
