## Drinking Water Well Sampling for PFAS Frequently Asked Questions

How do I return the drinking water well questionnaire? There are several options for returning your completed questionnaire:

In-person: Give to the person scheduling your sampling appointment at the Open House on May 22, 2025 between 5:00 p.m. and 7:00 p.m. at the Atlantic Elementary School gymnasium, or to the sampling team at the time of your sampling appointment.

**How do I schedule sampling?** Property owners with a drinking water well within the sampling area can schedule an appointment at the Open House or can call 1-877-MCOLF17 (1-877-626-5317) and leave a message with their contact information to schedule a sampling appointment.

What are the dates and times for sampling? The sampling will be conducted over two shifts from May 27 through June 3, 2025, and from June 5 through June 12, 2025. Sampling appointments will be available between the hours of 8 am to 5 pm. The sampling period may be extended as necessary. Accommodations can be made for property owners who may not be available during the sampling times. An adult (18 years of age or older) must be at the property during the sampling.

Who will be taking the sample? A sampling team of two Navy and Marine Corps contractors will collect the sample.

How long will the sampling take? The sampling will take less than an hour. The sampling team will take a sample from as close to the well as possible, preferably from a spigot that does not receive any treatment. The team will measure and record basic information about the water and will review the completed drinking water well questionnaire. Upon completion of sampling, a team member will provide a card with a sample identification number to you. The sample identification number is specific to your sample; please provide this sample identification number if you have any questions about your sample or sample results.

When will I receive the results? The <u>preliminary</u> results of your drinking water sample are expected within 30 days from when the sample was collected. The Navy and Marine Corps will call you (and your tenant, if your property is rented and we have their phone number) to let you know whether your drinking water sample contains certain PFAS at or above the DoD Interim Action Levels for PFAS in private drinking water. All preliminary results will be validated by an independent 3<sup>rd</sup> party. The validated results will be provided to property owners and tenants via letter approximately 3 months after sampling.

What actions will the Navy take to address PFAS in my drinking water? If your drinking water has certain PFAS at or above the DoD Interim Action Levels for PFAS in private drinking water wells, the Navy and Marine Corps will expedite implementation of an enduring solution, such as treatment or a new well. If your drinking water has PFOA and/or PFOS above 70 ppt, the Navy and Marine Corps will provide bottled water for drinking and cooking in your home; bottled water will be provided until an enduring solution can be implemented. Will my results be private? All references to results in official reports or in documents will include the sample identification number associated with your drinking water sample. By signing the right-of-entry agreement, you authorize the Navy and Marine Corps to share the coordinates (latitude and longitude) of your property along with the results of your drinking water well sampling with federal regulatory agencies supporting DoD's cleanup efforts if they request this information. Reports and documents will not contain your name or address.

Will health precautions be in place for sampling? Yes, if requested. If you would like our sampling team to take health precautions while sampling your well, please notify us of this when scheduling your sampling appointment.
