Frequently Asked Questions

How do I schedule the sampling? Property owners within the designated sampling area who use private wells for drinking water purposes can call **757-341-0450** to schedule a sampling appointment. Sampling appointments can also be scheduled in person at the Open House Public Meeting. The meeting will be held on Thursday, December 15, 2016, The Columbian Club, 1236 Prosperity Road, Virginia Beach, Virginia, from 4 to 7 pm.

How do I return the Homeowner Questionnaire? The questionnaire can be returned to the Navy at the Open House Public Meeting or at the time of your sampling appointment.

What are the dates and times for sampling? The sampling will be conducted from December 16, 2016 – December 22, 2016. Sampling appointments will be available between the hours of 9 am to 6 pm, Monday – Friday. There will be no sampling appointments on December 17 and 18, 2016. Accommodations can be made for property owners who may not be available during the regularly scheduled sampling times.

Who will be taking the sample? A team of two Navy-contracted professional environmental samplers will collect the sample. An adult resident (18 years of age or older) must be present during the sampling.

How long will the sampling take? The sampling will take approximately 45 minutes. The Navy representatives will take a sample from a location that does not receive any in-home treatment, if possible. If there is way to bypass a water treatment system, the sample will be collected from a faucet in your home. The team will also review the homeowner questionnaire.

When will I receive the results? The results are expected February 2017, depending on when the sample was obtained. The Navy will provide private notification of your results. If your drinking water is found to contain PFOS and/or PFOA above the EPA health advisory levels, the Navy will contact you in person to arrange for alternate water (e.g., bottled water) for drinking and cooking in your home until a long-term solution can be implemented. If your drinking water is found to contain PFOS and /or PFOA below the EPA health advisory levels, you will be contacted and informed of these results.

Will my results be private? All results will be kept confidential to the greatest extent possible. You will receive your results and all references to results in official reports will have a random number associated with your drinking water sample. Reports will not contain your name or address. The Navy will not share any personal information that you provide, such as name, address, email, or phone number to the extent permitted by law.
