The Navy is taking action near NAS Pensacola, Corry Station, and Saufley Field, to address certain per- and polyfluoroalkyl substances (PFAS) in drinking water wells due to past use of firefighting foam or other PFAS-containing materials on base.

The Navy has sampled the drinking water well at this property. The Navy has determined that additional action is needed to address PFAS in the drinking water well at this property.

A separate notification letter has been sent to the property owner to discuss options for addressing PFAS in the drinking water well at this property. No action is required on your part.
