

**NAVAL SUPPORT ACTIVITY SOUTH POTOMAC
 INVITES PUBLIC COMMENT ON
 THE PROPOSED PLAN FOR
 UXO 21 (Test Area 1)
 UNDER THE MUNITIONS RESPONSE PROGRAM**

In accordance with the requirements of the Comprehensive Environmental Response, Compensation and Liability Act (CERCLA) of 1980, Naval Support Activity South Potomac invites public comment on the proposed remedial action plan at Munition Response Site (MRS) UXO 21 (Test Area 1). The Preferred Alternative is presented in the Proposed Plan, which is available at one of the Information Repository locations listed below or online at the following link: <https://www.navfac.navy.mil/Divisions/Environmental/Products-and-Services/Environmental-Restoration/WASHINGTON/Indian-Head-NSF/Community-Outreach/>. Public comment begins on **April 1** and ends on **April 30, 2024**. Therefore, all comments must be postmarked or emailed no later than **April 30, 2024**.

A public meeting poster session will be held on **Tuesday, April 16, 2024, from 5:00 p.m. to 7:00 p.m.** at the Indian Head Senior Center, 100 Cornwallis Square, Indian Head, MD, 20640, to discuss the proposed remedial action. The Proposed Plan includes a No Action recommendation and meets the statutory requirements of CERCLA for protection of human health and the environment. Under this alternative, no response action will be performed at UXO 21, and no restrictions on land use are necessary.
