Meeting Summary

Mr. John Balinger presented opening remarks and introductions. Mr. Balinger reviewed the agenda for the meeting.

Brief on Current Issues

Ms. Dawn Hayes presented a summary of the work which has been conducted at SJCA and will be conducted in FY02 (see attached presentation). During and after the presentation, there were questions and discussion related to the presentation.

Mr. Bob Mann asked what Step 3 was for ecological risk assessment (ERA). Ms. Donna Caldwell and Mr. Ed Corl gave a brief review of the steps involved with an ERA.

Mr. Lyle Jackson of the Elizabeth River Project asked what TCE was and its use. Ms. Hayes explained that TCE stands for trichloroethene a solvent used as a degreaser and cleaner.

Mr. Jackson asked what is the criteria for the sampling depths. Ms. Caldwell describes the ecological and human health risk assessors requests different depths (0-6" depth for ecological and 12-36" depth human health) to best characterize the risks.

Environmental Risk Assessment

The RAB attendees were shown a 45-minute video tape on the Superfund Risk Assessment Process. The video focuses on human health risks assessments: exposure assessment, data collection & evaluation, toxicity assessment, and risk characterization.

Roundtable / Q&A

Mr. Mann and Mr. Kevin Lew commented that the video was informative and expressed that they would like to see other videos on related topics. Other topics could include a video on investigation field work.

Mr. Jackson gives a review of what the role of the Elizabeth River Project and the River Star Project.
