

Private Drinking Water Well Sampling Property Owner Questionnaire

If the drinking water consumed on your property comes from local groundwater (e.g., a private well), the Navy would like to sample drinking water to test for per- and polyfluoroalkyl substances (PFAS), at no cost to you. Properties that have drinking water provided by a municipality do not need to be sampled.
