The following comments on the Draft June 13, 2007, Restoration Advisory Board Meeting Notes are submitted on behalf of the Brunswick Area Citizens for a Safe Environment (BACSE). The Draft Notes were prepared by ECC and were received via email on July 12, 2007.

Meeting Attendees. Although Suzanne Johnson is a member of BACSE, she represents the Town of Brunswick at RAB meetings. Please correct her affiliation. David Chipman's affiliation is the only one that says RAB member. If he is listed as a RAB member, all the other RAB members should also be identified. Please correct accordingly.

5. Mere Brook Fish Tissue Study. The reason for the wait to perform the second round of fish tissue sampling was so that the fish population in Mere Brook would not be depleted, not so that the capping work could be done. Please correct.

6. Site 9 Status Update. Please add that there was a handout for the Site 9 presentation provided at the RAB meeting and attach a copy to the final notes. The second paragraph mentions yellow areas depicting the actual excavation extent. None of the maps in the handout include a yellow area showing the extent of excavation. Please either include such a map with the final notes, or add a notation to the text that the attached handout does not show the yellow area/extent of excavation.

8. Sites 1 and 3 and Eastern Plume Long-Term Monitoring Plan (LTMP). Please amend the third sentence so that it reads: The other letter dealt with the treatment of 1,4-dioxane.
