Introduction

The purpose of this document is to address comments to the Draft Action Memorandum for Site 88 Building 25, Operable Unit No. 15. The North Carolina Department of Environment and Natural Resources (DENR) provided the comments listed. The response to comments are provided in bold.

Comments on the Draft Site 88 Building 25 Action Memorandum
Marine Corps Base, Camp Lejeune, North Carolina**

General Comment

Can we provide an elevation contour map of the subsurface clay unit in the area of building 25?

An elevation contour map of the subsurface clay unit in the area of Building 25 is included as Figure 2-7 in Attachment A, the Final Engineering Evaluation and Cost Analysis for Building 25.

As follow up for the final Record of Decision, we need to determine how to address the high groundwater concentrations in the downgradient area near monitoring well MW-16IW. In the past groundwater concentrations in this area have been the highest including the source area wells.

This will be addressed in the Remedial Investigation/Feasibility Study. It is beyond the focus of this Action Memorandum.

Specific Comments

1. The last sentence of the second paragraph of the Executive Summary References Figure E-1 is missing. Figure E-1 has not been included in the Action Memorandum. Please make the appropriate corrections.

The figure was mistakenly omitted but will be included in the Final Action Memorandum.

2. The second paragraph on page 2-12 should state "significant compromising of joint integrity" or other appropriate language.

The wording will be corrected to state "compromising" as opposed to "comprising". This portion of the document is actually the final EECA. Corrected pages will be sent for the EECA.

3. Appendix C doesn't contain a detailed cost estimate for the preferred remedy Soil Mixing. Please make this addition or provide appropriate explanation.
