Please find enclosed the Draft Final Sampling and Analysis Plan (SAP) for the investigation planned at the Construction Equipment Department (CED)/Outfall 001 location identified during outfall maintenance activities in late 2008. The Draft SAP was submitted for your review on August 14, 2009. Comments were received from RIDEM on August 29, 2009 and from EPA on September 8, 2009. The Navy provided responses to both sets of comments on September 25, 2009. EPA provided a second set of comments on October 20, 2009.

The Navy has not provided formal responses to EPA's October 20, 2009 comments. However, the Draft Final SAP has been revised to address many of the comments provided by both EPA and RIDEM during last summer's review. We look forward to receiving your concurrence with this SAP and implementing the field investigation before the onset of winter.
