1. Enclosures (1) - (7) are draft reports which were recently received from Atlantic Division, Naval Facilities Engineering Command (LANTNAVFACENGCOM). They are provided to give you an overview of Installation Restoration (IR) FY-91 work planned at the three IR sites located on Naval Station, Norfolk: Camp Allen Landfill, Former Polychlorinated Biphenyl (PCB) Transformer Storage Area near Building P-71 and the CD Area Landfill. Work at the Camp Allen Landfill and Transformer Storage Area is scheduled to commence 22 January 91. Work is scheduled to be conducted February 1991 at the CD Area Landfill.

2. Commander, Naval Base, Norfolk will host a Technical Review Committee (TRC) meeting on 18 January 1991 to solicit technical comments from U.S. Environmental Protection Agency, Virginia, and City of Norfolk officials on work plans for several IR sites on the Naval Base Complex. The plans for the these three areas will be discussed at this meeting. Representatives from your staff are welcome to attend the TRC rehearsal meeting at 1030 a.m. on 17 January 1991 at the Breezy Point Officer's Club; however, so as not to overwhelm the TRC members, attendance of the actual TRC meeting will be restricted to Commander, Naval Base, Norfolk and LANTNAVFACENGCOM personnel only.
