Hi Mark -

I wish we had just run over and walked it that day on the way out. I did say I think there were two main sides that were potential "downhill" even though the slope was minimal. While I was down there I did not look at specifically where the existing samples were taken. I was just looking at slope in general. I recall we said 3 or 4 samples per side. I have attached a rough sketch of what might be appropriate based on what I recall and what we already have in the plan. It adds seven samples to the originally planned samples. I recall the sides to the north and west were down hill, I just can't remember how much of that north side seemed to be down hill. I also can't recall if the SW corner was downhill around the side or not. So I stuck one over there just around the corner. However, if you get out there, or if Tim or Heber can check it out, maybe they would be able to say if that corner is down hill or not and/or if the area further east along the north side is downhill. It may be that the one around the SW corner is not needed, but that there is more downhill area east of the original samples. In that case, just move the one sample from the SW side to the North side, east of the original samples. Bottom line is, what I had wanted was whatever areas seem to be downhill where water would most likely runoff and potentially transport and concentrate contaminants to be sampled. Clear as mud?
