

THIRD FIVE-YEAR REVIEW
Former Naval Air Warfare Center Trenton
West Trenton, New Jersey

The Department of the Navy, in cooperation with the U.S. Environmental Protection Agency (EPA) and the New Jersey Department of Environmental Protection (NJDEP), has completed the Third Five-Year Review of the remedies implemented at the former Naval Air Warfare Center (NAWC) Trenton, New Jersey. Former NAWC Trenton was in operation from 1951 to 1998.

The review provides an update of the status of remedial actions implemented since the second five-year review in 2008 and assesses progress made on the recommendations in the second five-year review. The review evaluates whether the remedial actions implemented remain protective of human health and the environment. The Navy has prepared a report to present the results of the third five-year review.

PUBLIC NOTICE

PLEASE TAKE NOTICE that PMG New Jersey, LLC (the Applicant), has filed an application with the Hamilton Township Planning Board for design waivers for the purpose of replacing the existing freestanding sign and adding 2 canopy signs as well as other signage for the Shell Gasoline Station located at 2006 Highway 33, Hamilton Township, Mercer County, New Jersey (located at the northern corner of George Dye Road and State Highway 33, and also known as Lot 33, Block 1952 as shown on the Tax Map of the Township of Hamilton (the "Property"). The Property is located in the HC (Highway Commercial) zoning district.

The Applicant is proposing to replace the two (2) canopy signs on the south and east elevations which contain the text "Shell" with Shell logo signs. These signs do not require any relief from the Planning Board given that they are smaller than the signs they replace.

In addition, the applicant shall seek the following relief from Section 160-124(i)(3)(f) of the Hamilton Township Land Use Ordinance for the proposed freestanding sign (replacing an existing freestanding sign):

In addition to the foregoing, the Applicant shall also seek any and all other variances, design waivers exception and/or other relief determined to be necessary or appropriate during the review and processing of the application by the Township of Hamilton, its staff and/or its professionals. Any persons affected by said application will be given an opportunity to be heard at a Public Hearing to be held on Thursday, the 13th day of March, 2014, at 7:00 p.m. at the Hamilton Township Municipal Building, 2nd Floor, Council Chambers, located at 2090 Greenwood Avenue, Hamilton Township, New Jersey.
