**Proposed Plan
for
Site 29 - Lee Pond
Naval Weapons Station Yorktown**

The Department of the Navy invites public comment on the Site 29 (Lee Pond) Proposed Plan that presents information pertaining to proposed final clean-up alternative at Naval Weapons Station (WPNSTA) Yorktown located in Yorktown, Virginia. Site 29 is a 4.1-acre freshwater pond located in the east-central portion of WPNSTA Yorktown. In accordance with the Code of Federal Regulation, 40 C.F.R. § 300.430(f)(2), the Proposed Plan presents assessments of risk to human health and the environment. The proposed final clean-up alternative outlined in the Proposed Plan is No Action. No Action was selected based on a review of site data that demonstrates there are no unacceptable risks to human health or the environment from unlimited use and unrestricted exposure to soil, groundwater, surface water, and sediment at Lee Pond. Because there are no unacceptable risks, evaluation of action alternatives was not necessary.

The Proposed Plan is based on findings contained in documents that are part of the Administrative Record for WPNSTA Yorktown. The Administrative Record provides background information on Site 29, as well as remedial investigations conducted at the site.
