We have reviewed the Final Draft of the Supplemental RCRA Facility Investigation (RFI) Report for Site 11, the Old Camden County Landfill, at Naval Submarine Base, Kings Bay. By this letter we deem that the RFI is complete. This determination is made without comment regarding the general or specific content of the report, but rather to document EPD's conclusion that the data reported are adequate to design a corrective action system for the site. No further characterization will be required at this time.

As required under Condition III.D.2. of your Hazardous Waste Facility Permit, Number HW-014(S)(2), and Condition 4. of Corrective Action Consent Order EPD-HW-1072, Naval Submarine Base, Kings Bay is obligated to submit, within ninety (90) days of the date of receipt of this letter, a Corrective Action Plan to implement corrective action at Site 11, and an application to modify your Permit to incorporate corrective action.
