The enclosed draft submittals have been transmitted to you prior to the due date of June 2, 1991. Please review the primary and secondary documents and provide to us your comments by August 31, 1991. We will respond and incorporate your comments as appropriate into the next submittals.

We would like to tentatively schedule the next Remedial Project Managers (RPM) and Technical Review Committee (TRC) meetings within the 90-day review/comment period of the project submittals. We feel that an appropriate time would be on July 25, 1991. Scheduling the meetings on this date would allow the RPM's and the TRC members the opportunity to review the draft submittals and be prepared to discuss future investigative efforts at these sites as well as any additional action items.

The draft proposed Phase II workplan recommendations for groups A through E (Sites 1, 2, 11, 12, 13, 14, 15, 24, 26, and 30) have been prepared in the submitted format per discussions and negotiations between Nancy Dean (EPA), Eric Nuzie (FDER), David Criswell (SOUTHDIV), Allison Drew (EPA), and Suzanne Sanborn (SOUTHDIV). These recommendations upon review/comment and eventual approval will be incorporated into the previously approved workplans (July 1990) and appendices. Minor revisions to the previously approved workplan will need to occur in order to reference the addition of appendices. The minor revisions will include changes to the Table of Contents, additional narrative in Section 14, and additional tabs for the appendices.
