**Naval Air Station Pensacola  
Restoration Advisory Board Meeting Minutes  
March 25,1997**

1. Call to Order:

The meeting was called to order by Community Co-Chairperson, Lisa Minshew. The minutes of the 25 February 1997 meeting were reviewed and approved.

2. Community Concerns

Jerry Westmoreland stated that he had several contacts concerning the sanitary sewer line break which occurred on March 18.

3. New Member Effort And Review RAB Applications

**Mr.** Keith Cornett stated that two RAB member applications had been picked up by individuals but had not been returned. A press release concerning new membership had been sent to the Pensacola News Journal but nothing appeared in the paper. In addition, the letter from the RAB to the approximately 250 people on the mailing list which was approved during the February 25, 1997 RAB meeting will be mailed on March 26, 1997.

Ms. Lisa Minshew stated that it would be helpful if each RAB member had a few membership applications to distribute to prospective individuals. Mr. Cornett stated that he would provide those each community member.

4. Review RAB Charter

The RAB Charter was reviewed and no changes were recommended. It was noted that the 2-year term of the existing members is nearing completion and new members as well as additional members are needed. A lack of community interest is a major obstacle.

5. Update on BLAB Appearance

**Ms.** Lisa Minshew and Mr. Jerry Westmoreland stated that the BLAB television appearance went well although there was only two telephone calls. The concern of the calls was that there are areas on the base that are being studied that do not warrant investigation.

6. Pensacola Bay Report

Mr. Bill Hill stated that the Navy is still perusing a no further action alternative for Pensacola Bay with the exception of Site 2.

7. Progress Report

the Explanation of Significant Differences for Site **39**,  
the draft Proposed Plan for Site **17** recommending No Further Action, and  
the Executive Summary for Operable Unit #2 Remedial Investigation Report.
