8. Other Business

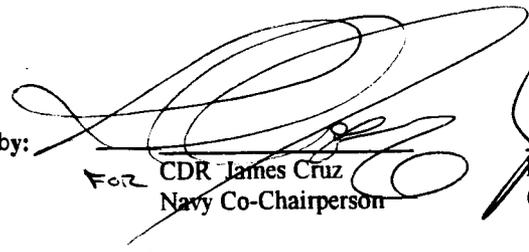
Mr. Jesse Rigby ~~moved~~ and John ~~Early~~ seconded that Mr. Ucci become a member of the RAB.

The next RAB meeting is scheduled for October 6,1998.

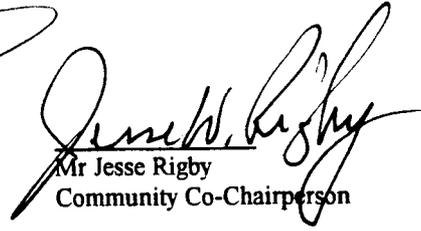
**9. Adjournment:**
