- Loc_ID
- Northing (Y)
- Easting (X)
- Top of Casing OR ground surface elevation
- Sample top
- Sample bottom
- Sample date
- Parameter
- Result
- Units

- o data qualifier (e.g. U, J, etc)
- o Coordinate system - e.g. NAD83, State Plane, feet

The Navy has authorized Tetra Tech to transfer the data to you (see the attached e-mail from Mr. Robert Fisher, P.G.; NIRIS Coordinator – NAVFAC SE). To view the information on the disc requires ESRI's ArcGIS (ArcMap). The CD includes all of the .DBF tables and shape files. Julie, Patty:

I have an update on the information requested. As Julie mentioned, much of the data requested is contained within the EGIS CD used at partnering team meetings and I have been given permission to release this immediately - permission was required to release the non-environmental special data for the facility (not the environmental data).

To view the information on the disc requires ESRI's ArcGIS (ArcMap). The CD includes all of the .DBF tables and shape files. We will also include the MDX file, which if launched, provides you with a customized analytical query tool in a simple to use drop down menu. I just checked, and the analytical data will be current as of the end of January 2011.

The CD will be ready by tomorrow and copies will be sent out immediately. Expect delivery early next week.

Finally, I can sponsor you for the PKI/NIRIS access and push that through quickly. This way you will have access to all of the customized features that have been built and will always have the most up-to-date data.
