## OPERABLE UNIT 1

**Current Status:** OU-1 includes Sites 6, Building 41 (Aircraft Intermediate Maintenance Facility); 7, Building 459 (Navy Exchange Service Station); 8, Building 114 (Pesticide Storage Area); 14, Former Fire Training Area; 15, Buildings 301 and 389 (Former Storage Area); and 16, C-2 CANS Area (Shipping Container Storage). A Final Remedial Investigation (RI) report was submitted for Sites 6, 7, 8, 15, and 16 and a Draft Feasibility Study (FS) report was submitted for Sites 6 and 15. During discussions of each site, data gaps were identified that needed to be resolved prior to making decisions on site outcome. Site 14 was transferred from OU-2A to OU-1. Data gap sampling is completed for Sites 6, 14, 15, and 16. In order to expedite transfer of property located in the northwest portion of Alameda Point for the City of Alameda to construct a golf course, the Navy has split reporting of data for OU-1 into two separate reports, one for Sites 14 and 15 and the one for Sites 6, 7, 8, and 16. It is anticipated that Sites 7 and 8 will be transferred to the Corrective Action Program. Based on data gap sampling the BCT concurred that a removal action was not necessary at Site 15.
