RESPONSES TO COMMENTS AND DRAFT FINAL REMEDIAL INVESTIGATION  
REPORT, ALAMEDA POINT, ALAMEDA, CALIFORNIA

In accordance with the Alameda Naval Air Station Federal Facility Agreement, Section 14, the Navy is requesting a 47 day extension on the submittal date for the Operable Unit 2B (OU-2B) Sites 3, 4, 11, and 21 Responses to Comments and the Draft Final Remedial Investigation (RI) Report.

Based on the Site Management Plan, of September 17, 2004, the OU-2B, Site 26 Draft Final RI, along with responses to comments on the draft document, was scheduled for submittal on January 14, 2005. Due to contractual issues and extensive comments received on the draft document, the Navy requested an extension of the due date to March 16, 2005. As a result of the contractual issues, the contract was not awarded until February 17, 2005. Therefore, the Navy is requesting an additional 47-day extension to complete the draft final document. All due dates of future OU-2B documents would also be delayed by an additional 47 days.
