

U. S. Navy Prepares to Observe Conditions During Channel Maintenance Activities at Little Salado Creek near NASA Crows Landing Flight Facility

The Navy will be observing channel maintenance activities that will be conducted by the San Luis & Delta-Mendota Water Authority in early June 2004 along Little Salado Creek near NASA Crows Landing Flight Facility, California. During June 2003, following the completion of routine channel maintenance activities in this area, two 20-millimeter rounds were discovered in the sediments that were removed from the channel. The Stanislaus County Sheriff responded by retrieving and destroying the rounds. If munitions items are discovered during the 2004 maintenance activities, the Sheriff will respond. Documents pertaining to the June 2003 incident and plans for observing the June 2004 channel maintenance activities are available for public inspection in the Navy's Comprehensive Environmental Response Compensation and Liability Act Administrative Record Files and the information repository at the Stanislaus County Library, Patterson Branch on 46 North Salado, Patterson, California (Telephone: 209 892-6473).
