The Department of the Navy (Navy) is conducting environmental investigation activities at the Long Beach Naval Complex (LBNC) as part of the Installation Restoration Program (IRP). The goals of the IRP are to identify, investigate, and cleanup contamination from past activities involving hazardous substances. The Navy has partnered with environmental agencies and the community to carefully coordinate the environmental restoration of the LBNC under this program.

The Department of Defense (DoD) issued guidance for improving public involvement opportunities. This guidance recommends that the installation establish a Restoration Advisory Board (RAB) as part of the IRP.

The LBNC established a RAB in April of 1994, which typically meets bi-monthly. The RAB consists of 17 local community members, 4 regulatory agency representatives and 6 Navy personnel. Membership in the RAB is voluntary. Each RAB member participates in the review of environmental investigation documents and provides comments on these documents. In addition to reviewing documents, each RAB member is entitled to bring any community issue related to environmental activities at the base to the attention of the board.

This meeting is OPEN TO THE PUBLIC and is intended to provide an open forum for the community to attend and participate in all aspects of the investigation and cleanup of the Long Beach Naval Complex.

The Agenda for the 17 October meeting includes a discussion regarding the Navy's participation on the Internet System, the Reuse Screening Process and the BRAC Funding Process (specifically at the Long Beach Naval Complex).
