Subject: Tentative Cease and Desist Order

Dear Captain Moyer:

This letter is written to confirm that the tentative Cease and Desist Order for Moffett Field has been deferred until the September 16, 1987 Regional Board hearing. As requested, the tentative order was deferred one month to allow the Navy additional time to adequately respond to the order.

The August 6, 1987 letter from Captain Davis suggests that I agreed to defer the deadline for responding to the tentative order until September 15, 1987, which is one day prior to the scheduled hearing date. As Tom Berkins of my staff has previously explained to Commander Sims and Captain Harris, I did agree to defer the tentative order until the September 16th Board hearing. However, in order for my staff to adequately respond to your comments, we request that any comments or recommendations you may have concerning the tentative order be received by the Regional Board on or before August 28, 1987. In addition, in order for your comments to be included in the agenda package to be transmitted to the Regional Board members we must receive your written comments no later than September 4, 1987.
