Remedial Investigation/Feasibility Study (RI/FS) planning documents are being prepared for Naval Air Station (NAS), Moffett Field, California. The National Oceanic and Atmospheric Administration (NOAA) has commented on the NAS Moffett Field, Sampling Plan dated June 1987. NOAA's comments, enclosure (1), expressed concern for the National Wildlife Refuge. Since then the Sampling Plan has been updated, December 1987, to follow the Environmental Protection Agency (EPA) procedure and to include additional sites. Enclosure (2) is the five volume Work Plan set dated December 1987 for NAS Moffett Field.

Per conversation between Ben Crabb of your office and Chloe Jue of my staff on 23 Dec 87, the Navy informed the San Francisco Bay National Wildlife Refuge office of their intentions to finalize RI/FS planning documents and wanted to know the extent of your office's involvement during the RI/FS. NAS Moffett Field is working under a tight time schedule and would like to know what your office's involvement will be by 5 January 1988. If you have comments on the Work Plan, we request that comments be submitted to the Regional Water Quality Control Board (RWQCB) by January 15, 1988. It is our understanding that the RWQCB will solicit and consolidate comments from involved agencies and provide comments to this Command.
