Subj: OFFSITE AREA (WETLAND) INVESTIGATION AT NAVAL AIR STATION, MOFFETT
FIELD, CALIFORNIA

We are preparing an addendum to our Remedial Investigation (RI) Work Plans to address your concerns as well as those from the U.S. Fish & Wildlife on an investigation of the offsite (wetland) areas at Naval Air Station (NAS), Moffett Field. The addendum will concentrate on sediment sampling at these offsite areas to identify whether any contaminants have been released from NAS Moffett Field onto the adjacent aquatic environment. It is anticipated that the offsite areas to be investigated will include areas like, Stevens Creek, Jager Slough, Devil's Slough, Guadalupe Slough, drainage canals, other wetland areas and obvious drainage paths. The addendum workplan will be submitted for your review in fourth quarter of 1988.
