## Record of Decision Now Available for Moffett Federal Airfield Superfund Site 22 Landfill



A Record of Decision (ROD) for the Site 22 landfill at Moffett Federal Airfield was signed between the Navy and environmental regulators on June 5, 2002. The ROD documents the Navy's remedy for preventing human exposure to buried wastes at Site 22 and monitoring potential contaminant releases to groundwater and the atmosphere.


