Record of Decision Now Available for Moffett Federal Airfield Superfund No Action Sites

A Record of Decision (ROD) for the No Action Sites at Moffett Federal Airfield was signed between the Navy and environmental regulators on August 22, 2002. The ROD documents the Navy's remedial action (no action) for four sites: Site 23 – Golf Course Landfill Area 3; Weapons Storage Bunkers; Upland Soils; and HHRA Exposure Area 4158.


