Record of Decision Now Available for Former NAS Moffett Field Site 27, Northern Channel

A Record of Decision (ROD) for Site 27, the Northern Channel, at the former Naval Air Station Moffett Field was signed by the Navy, San Francisco Bay Regional Water Quality Control Board and the U.S. Environmental Protection Agency on July 7, 2005. The ROD documents the final remedy for addressing risks to the environment by removing contaminated soil and sediments and taking them off site for disposal at an approved facility.
