## Moffett Field Hangar 1 Informational Poster Session and Alternatives Workshop

You are invited to attend an informational poster session and workshop to discuss alternatives for cleaning up Hangar 1 at the former Naval Air Station Moffett Field. This is another opportunity to get more information, provide comments to the Navy and learn how the Navy will determine the best environmental actions for the hangar. The Navy is evaluating alternatives, many provided by the public, for addressing cleanup at Hangar 1 in an Engineering Evaluation/Cost Analysis (EE/CA).

This informational poster session and workshop is being held to involve the public in the Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA) process. In addition, because Hangar 1 is listed on the National Register of Historic Places, this event will comply with Section 106 of the National Historic Preservation Act.

During the informational poster session, Navy, NASA and regulatory agency representatives will be on hand to answer your questions about contamination at Hangar 1, the EE/CA process and the cleanup alternatives being considered.

During the workshop, the Navy will discuss how each alternative either meets or does not meet evaluation criteria and you will be able to provide feedback. You are also encouraged to express your views on ways to resolve any adverse effects the proposed cleanup actions may have on Hangar 1.


